SCHEDULE OF COSTS for the Arbitration Rules of the Chamber of Commerce and Industry of Southern Sweden

The Chamber of Commerce and Industry of Southern Sweden <u>Registration Fee</u> is SEK 8,000 exclusive of value-added tax.

The Registration Fee is non-refundable and constitutes a part of the Administrative Fee, see below. The Registration Fee shall be credited to the Advance on Costs to be paid by the Claimant.

The Registration Fee, totalling SEK 10,000 inclusive of value-added tax, shall be paid to Bankgiro No. 514–1213.

Mark the payment with the parties in the case.

For remuneration to the Arbitration Council (Administrative Fee)¹ and fees to the Arbitration Tribunal (Ordinary and Simplified Proceedings) and Mediators, see below.

However, the Arbitration Council may decide upon a different distribution. Amount in dispute refers to the aggregated value of the claim, the counterclaim and any set-off claims. The amounts stated below are exclusive of value-added tax and social security contributions (if applicable).

MEDIATION

ADMINISTRATIVE FEE

The Administrative Fee for the mediation is SEK 16,000 (exclusive of value-added tax).

MEDIATOR'S FEE

Amount in dispute refers to the aggregated value of the claim, the counterclaim and any set-off claims. The amounts stated below are exclusive of value-added tax and social security contributions if applicable (costs for premises, refreshments, etc. may be added).

Amount in dispute (SEK)	Mediator's fee (SEK)
Under 500,001	20,000 (preparation of the case) + 20,000 for each day of mediation hearings
From 500,001	40,000 (preparation of the case) + 40,000 for each day of mediation hearings

If several disputes are handled within the same mediation proceedings, the starting point is that the mediator's fee shall be set to 150% of the higher of the fees that would have been payable according to the table if separate mediation proceedings had been held.

The Arbitration Council may decide to deviate from the fees listed above if the mediation case in question is unusually complex or time-consuming. The amount may be reduced if the matter is terminated prematurely or if the Arbitration Council considers that there are other reasons to do so.
