ATA carnets

The ATA carnet is an international customs passport that is valid in around 70 countries to temporarily bring goods in and out without making a customs declaration or leaving a cash deposit corresponding to customs and other import charges.

An ATA carnet can be used for professional equipment, goods for trade fairs and exhibitions and product samples. The cost varies depending on how many countries are to be visited, the value of the goods, how quickly the carnet is needed and whether the company is a member of the Chamber of Commerce or not.

Export document

When importing to some countries, the country of origin of the goods must be proven with special certificates of origin. For these to apply, they must be issued by the Chamber of Commerce. In some cases, it is also required that other export documents, e.g. the company's invoices and price lists, must be legalized by the Chamber of Commerce.
