### Fees / Terms of payment

In conjunction with the deposit, the Depositor shall pay an initial fee of SEK 7 000 (for members of Sydsvenska Industri- och Handelskammaren; SEK 9 500 for others), which shall include the annual fee for one (1) year. Each time the deposited Source Code shall be changed, a fee, currently equal to SEK 1 000 (for members of Sydsvenska Industri- och Handelskammaren; SEK 1 350 for others), shall be charged. If the term of this agreement is extended, the Depositor shall pay a deposit fee, which shall be determined annually by the Depository, for each twelve-month period of the extension, or any part thereof. The fee is currently SEK 5 000 (for members of Sydsvenska Industri- och Handelskammaren; SEK 6 800 for others). The fee for changing the Source Code shall be established in a similar way. The amounts mentioned herein are subject to VAT. The above fees shall be invoiced to the Depositor.
